CANADIAN PLANT BREEDING & GENETICS AWARD

A National Award of Excellence to Recognize the Contribution of Plant Breeders to the Success of Canada

Sponsored by the Canadian Seed Trade Association and *Germination*

The Canadian Plant Breeding & Genetics Award is presented annually to a public or private sector researcher who has made a significant contribution to the advancement of Canadian plant agriculture through research in plant breeding and genetics. The recipient will have demonstrated excellence in one or more of the following areas:

- 1) World class application of the science of plant breeding and genetics;
- 2) Applying creativity and commitment to achieving technical success;
- 3) Significant contribution to the advancement of agricultural productivity in Canada and/or abroad.

The award consists of an engraved plaque donated by *Germination* magazine. It is presented by CSTA and *Germination* at an awards ceremony at CSTA's annual convention. CSTA pays the costs of travel, accommodation and meeting registration for the award winner and an accompanying person.

Eligibility of Nominators

Nominations for the Canadian Plant Breeding & Genetics Award will be accepted from anyone who has knowledge of the nominee. The nominator need not be a member of the CSTA.

Eligibility of Nominees

Nominees for the Canadian Plant Breeding & Genetics Award need not be members of the CSTA. Nominees do not necessarily have to be based in Canada, however their contribution to the advancement of plant genetics must have predominantly benefited Canada. It should be noted that in the selection process, preference will be given to candidates whose work is/was conducted in Canada. The nominee must be living at the time of the nomination. The CSTA reserves the right to not present the award if no nominees meet the criteria. The CSTA also reserves the right to modify the eligibility criteria.

Selection Process

CSTA's Executive Director will receive and review nominations for completeness. All complete nominations will be presented to the CSTA Board of Directors for a decision at its February board meeting. Nominations that are not selected may be carried over for submission to the Board in the following two (2) years.

Notice and Process

Following the selection, the nominator will be notified and asked to notify the award winner that he/she has been chosen. Once the recipient has been notified by the nominator, CSTA will contact the winner to provide additional details. CSTA membership will be notified in the spring. A news release announcement will be made immediately following the awards ceremony.

Nomination instructions

Any person may submit a nomination. The nominee will be considered for three (3) years without submission of an entirely new nomination package. Additional supporting information may be submitted the second or third year.

A call for nominations will come from the CSTA annually in November. Nominations should be submitted to CSTA's Executive Director no later than December 15th of each year. The nominations will be considered by the CSTA Board at its February board meeting.

Nominations should be accompanied by the following supporting data and information.

- 1) Name, position, affiliation, address, telephone, email of nominee
- 2) Name, position, affiliation, address, telephone, email of nominator
- 3) Nominee's Credentials
 - a) Education, academic degrees
 - b) Honours, awards, or recognition received
 - c) Professional positions held
- 4) Qualifications of Nominee
 - a) Outstanding application of the science of plant breeding and genetics throughout a career
 - i. Specific plant improvements and their significance
 - ii. Creativity in research
 - iii. Products developed, i.e. cultivars, hybrids, and inbreds
 - b) Significance and originality of specific research projects or studies
 - i. Project description
 - ii. Uniqueness of results (attach documentation as necessary)
 - iii. Application of plant improvement

- c) Research activities that extend beyond Canada (attach supporting letters)
 - i. Describe programs and significance
 - ii. Percent of time involved
- d) Contributions of the nominee to the CSTA and the Canadian commercial research community (commercial nominees)
 - i. Committee involvement
 - ii. Contributions to CSTA policy and initiatives
- e) Membership in scientific and professional societies; outline of services performed for these societies
- f) Major publications
- g) Two supporting letters for the nomination

CSTA must receive the nomination no later than December 15th.

Send the completed nomination with accompanying letters of support to the attention of Teresa Neuman, Manager, Stakeholder Relations. Nominations may be submitted by e or mail. Receipt of all nominations will be confirmed with the nominator by CSTA staff.
